Victoza (liraglutide)

INDICATION: Type 2 diabetes mellitus and to reduce the risk of cardiovascular mortality in patients with type 2 diabetes mellitus with cardiovascular disease.

HOW SUPPLIED: 18mg/3mL pre-filled pen solution for injection

DAILY DOSING:

- o.6mg under the skin once daily x 1 week (to decrease GI side effects)
- 1.2mg under the skin once daily thereafter
- 1.8mg is indicated if patient needs additional glycemic control

*If patient is also receiving insulin, use two separate injections sites

CONTRAINDICATIONS:

- Patients with a personal or family history of thyroid cancer (MTC/MEN2)
- Patients with type 1 diabetes mellitus or DKA

PRECAUTIONS:

- Hypoglycemia in patients on other diabetes medications
 - o Decrease does of insulin demetir
 - Decrease dose of sulfonylureas
- Use cautiously in patients with gastroparesis

SIDE EFFECTS:

- Hypoglycemia
- GI nausea, vomiting, diarrhea, constipation
- ↑ LFTs and pancreatitis
- Injection site reaction

DRUG INTERACTIONS: VICTOZA® delays gastric emptying. May impact absorption of concomitantly administered oral medications. Chloroquine/hydroxychloroquine (monitor blood glucose if patients are on these medications)

USE IN SPECIFIC POPULATIONS: No renal or hepatic dose adjustment needed

DID YOU ALSO KNOW??

Liraglutide is also indicated for treatment of obesity under the trade name Saxenda

- 3mg/day subcutaneous injection (using same titration as Victoza)
- For patients with a BMI $\geq 30 \text{kg/m}^2$ or $\geq 27 \text{kg/m}^2$ with at least 1 weight related comorbidity (HTN, dyslipidemia, type 2 diabetes mellitus)
